It's also time to begin thinking about the DSC Board of Directors for 2021-2022. I would like to hear your suggestions for candidates for the new Board. If you or someone you know would like to serve on next year's Board, we need your input now. Please send me an email at irvingreed4@gmail.com, or a text to (817)851-8715, with your recommendations. A candidate for a position on the Board should be able to attend monthly Board meetings, Happy Hours and other Club events whenever possible.

As President-Elect, I will serve as Chairman of the Nominating Committee, which is composed of the current Club President, Lynn Erickson, two Past Presidents and four members-at-large. The committee will meet in the near future to develop the slate of officers. The slate will be presented to the membership in the Powder Hound newsletter and will be voted upon at the General Membership Meeting.

Following is an abbreviated list of the DSC Board positions and their responsibilities:

- **President-Elect:** Supports the President & assists the VP's to become familiar with each Board position.
- **Treasurer:** Works closely with the Club Administrator to ensure accurate and timely financial tracking and reporting. Accounting/tax knowledge required.
- **Secretary:** Records and distributes minutes of all Board & General Membership meetings.
- **Trip VP:** Skiing oriented member with previous trip leader experience. Acts as liaison with Texas Ski Council to ensure DSC is a member in good standing. Attends the annual Bid Fest. Works with resorts and airlines to develop the Club's trip schedule. Recruits trip leaders, provides formal trip leader training, and maintains/updates the trip database.
- **Membership VP:** Outgoing, organized, champion of the Club and all new members. Markets Dallas Ski Club membership, maintains Volunteer Bank, organizes New Member recognition events and is responsible for Annual Membership Drive.
- **Happy Hour VP:** Plans our monthly Happy Hours and recruits members to help at the Happy Hour.
- **Activity VP:** Outgoing, organized with the ability to plan a party and manage a budget. Will plan and implement diverse social schedule to appeal to all DSC members. Creates a committee to help plan the theme, location, refreshments and entertainment for each activity.
- **Marketing VP:** Develops a marketing plan to bring in revenues through advertising and selling logo merchandise. Requires a business/marketing orientation with the ability to solicit advertising for the Powder Hound, our website and Directory.

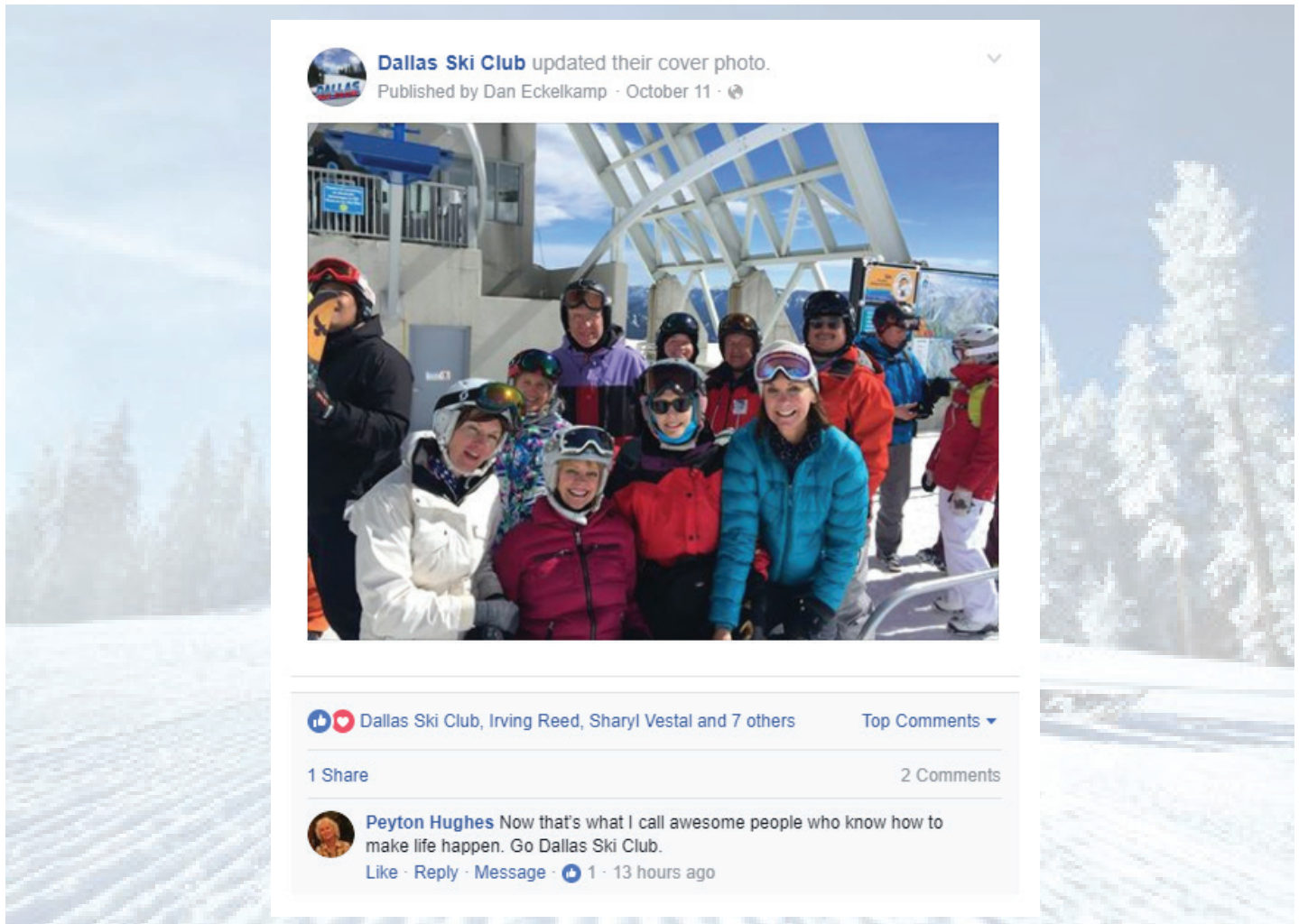
