# SNOWBIRD SKI TRIP

JANUARY 7 – 14, 2023

Joyce Bartell and Michael Hines led 32 people on this trip, with 2 of those joining us for an eventful party pack. We took a non-stop flight from Dallas Love Field to Salt Lake City airport with a 40-minute shuttle ride making two necessary “supply” stops on the way to the hotel.

Snowbird, Utah, is a unique destination for the Dallas Ski Club because Dick Bass was a founding DSC member and an early DSC President. He also developed Snowbird and opened it in 1971. Snowbird and Alta have a reputation...it snows...it snows a lot and it's light and fluffy.

The group stayed at the Cliff Lodge at Snowbird, one of North America's most iconic ski lodges. The group enjoyed ski-in/ski-out convenience and excellent service with a luxurious resort experience. The lodge has an on-site ski rental shop and complimentary ski lockers and is within walking distance of Snowbird's pedestrian village. The Spa, on the ninth floor, provided all the services you would expect and was enjoyed by many of the participants!

The following day, we had a Welcome Breakfast with a full buffet complete with an impressive omelet station. Snowbird resort staff made a 20-minute presentation and had a raffle. The many raffle winners picked up some nice Snowbird swag. Following breakfast, most participate in one of two complementary mountain tours lasting 2 ½ hours.

Sunday was an enjoyable day for skiing. Every day, we started off the mornings with temperatures in the high teens and warming up to the mid-20s but never above freezing.

Monday was another fantastic day of skiing. That night we had a group dinner at the Wildflower restaurant in the Iron Blossom Lodge. The group was seated at four tables and served a delicious meal of wings, pizza, and salad.

Tuesday, and throughout the week, people could choose to ski at the Alta Ski area if they had an Ikon pass or paid \$60/day to upgrade their Snowbird lift ticket. Alta is noted for not allowing snowboarders. If weather conditions are suitable, you can even ski from Snowbird to Alta, otherwise, there was a local shuttle and transit bus that only took about 5 minutes.

Wednesday was probably not the best ski day of the trip, but it made for a great Spa Day! Everyone woke up to an Interlodge event that lasted until 11:00 am. “WHAT IS INTERLODGE? An Interlodge event is when snow levels are so great and avalanche danger is extreme that patrons and employees of Snowbird are confined to resort buildings...” After 11:00, we were permitted to move from building to building only. Some lifts along with the main highway from Salt Lake City opened around 2:30 pm. As a result, the group Après ski had to be canceled.

**Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19 – updated 11-2-20**

WHEREAS, the coronavirus a/k/a COVID-19 has been declared a worldwide pandemic by the World Health Organization, and is extremely contagious and believed to spread mainly from person-to-person contact; and federal, state, and local governments and federal and state health agencies recommend social distancing, e.g., staying six feet from others, and have, in many locations, prohibited the congregation of groups of people; and

WHEREAS Dallas Ski Club ("DSC") cannot guarantee that I will not become infected with COVID-19 or a variant thereof (hereinafter included in the term "COVID-19"); and that attending DSC events, including Happy Hours, parties, trips or the like ("Events") could increase my risk of contracting COVID-19;

NOW, THEREFORE, for allowing me to participate in various DSC activities and other good and valuable consideration, I hereby agree as follows:

1. I will comply with DSC's requests, if any, regarding precautions to be followed related to the possibility of becoming infected with or infecting others with COVID-19.
2. I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by attending or participating in DSC events, trips or other activities, and that such exposure or infection may result in personal injury, illness, permanent disability, and death. **I understand the risk of becoming exposed to or infected by COVID-19 while at or participating in a DSC function may result from the actions, omissions, or negligence of DSC, myself or others.**
3. I voluntarily assume all of the risks and accept sole responsibility for any injury or harm to myself, or others who may, or may claim to have, become infected by or through me on account of or related to my having been infected by COVID-19, or otherwise harmed by my having attended or participated in a DSC activity, including, but not limited to, injury, disability, death, illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my attendance at or participating in a DSC function, and **I hereby release, discharge, hold harmless, and agree to defend, indemnify and covenant not to sue DSC, its members, officers, trip leaders, or other participants in or related to the relevant DSC related activity (the "Released Parties"), of and from any claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the DSC, its members, guests, officers or trip leaders, whether a COVID-19 infection occurs before, during, or after participation in any DSC event, activity or trip.**
4. This Waiver and Release shall be binding upon the person signing it, their successors, heirs and assigns, and shall inure and apply to the benefit of the Released Parties, their successors, heirs and assigns. All matters affecting the interpretation, form, validity, and performance of this Agreement shall be decided under the laws of the State of Texas. In the event it is necessary to file suit to enforce this Waiver and Release, the prevailing party shall recover court costs and reasonable attorney's fees from the other party.

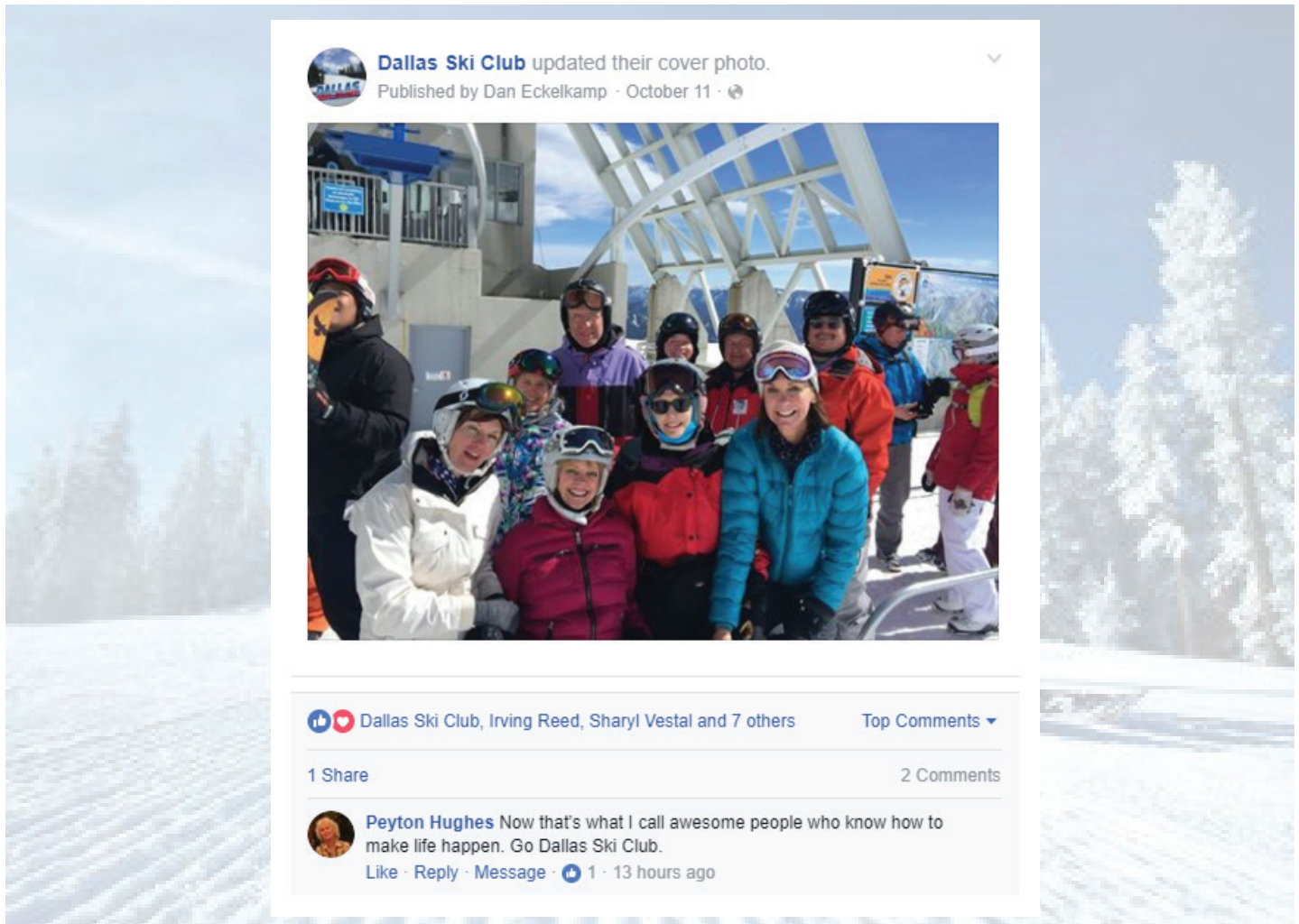
